Insurance for your home contents (see insurance product information document)

When you take out this insurance your household goods and contents will be insured whilst in your home against events such as fire, theft and flooding. The insurance also covers theft of your keys and the contents in your freezer. There is also cover for personal liability.

Accidental damage and cover away from your home are not covered as standard other than as detailed in the enclosed insurance product information document. However, a full accidental damage option is available at an additional cost (see cost of insurance table and insurance product information document).

There are also optional extras available for you to choose from including personal belongings, wheelchair and hearing aid cover for an additional premium. This gives much wider cover for the optional extras. It protects your belongings if they are stolen or accidentally damaged or if you simply lose them. Cover is worldwide so protects items you take away from the home as well as giving extra cover in your home or garden (please refer to the Cost of Insurance table attached) Please refer to the enclosed insurance product information document which details the main circumstances that are covered (e.g. fire, theft, water damage). There is no cover for wear and tear or mechanical breakdown. A specimen policy booklet is available on request.

Special low, minimum sums insured

The lowest amount that can be insured is £4,000.



"New-for-Old" insurance

All your home contents are covered by the policy on a 'new for old' basis, with the exception of linen and clothing which will be replaced at their current cost, less an amount for wear and tear. When you are working out the cost of your insurance, you will need to work out how much it will cost to replace the full contents. If you under value your contents this will mean that if you claim you may not get the full value of your claim.

Payment of the premium

You will need to decide how you would like to pay the premium. The options available are:

- · Monthly by payment card

Keeping up the payments

Start date

Insurance starts when Wessex Group informs you that you have been accepted onto the scheme. Wessex Group will write to you with details of your insurance payments and the date when you should start paying. Special Notes

- If during the period of your insurance cover your home is likely to be unoccupied (e.g. if you are in hospital, extended holiday) for more than 60 consecutive days you will have to advise Wessex Group.
- Remember, it is your responsibility to ensure that the sum insured is sufficient to cover all your household items and personal effects.

Personal information we collect and how we use it

- to support legitimate interests that we have as a business. We need this to:
